### Introduction

All Local Authority (LA) maintained schools have a similar approach to meeting the needs of pupils with special educational needs and /or disabilities (SEND) and are supported by the Local Authority (LA) to ensure that all pupils, regardless of their specific needs, make the best possible progress in school.

All schools are supported to be as inclusive as possible, with the needs of pupils with special educational needs and disabilities being met in a mainstream setting wherever possible.

The broad areas of SEND need are:

- Communication and Interaction
- Cognition and Learning
- Social, Emotional and Mental Health Difficulties
- Sensory and/or Physical

### What is the Local Offer?

#### **The LA Local Offer**

The Children and Families Bill was enacted in September 2014. From this date Local Authorities (LA) and schools are required to publish and keep under review information about services they expect to be available for children and young people with special educational needs (SEN) aged 0-25. The LA refers to this as the 'Local Offer'.

The intention of the Local Offer is to improve choice and transparency for families. It will also be an important resource for parents in understanding the range of services and provision in the local area.

### What is the Special Education Needs Information Report?

#### **The Special Education Needs Information Report**

Schools utilise the LA Local Offer to meet the needs of SEND pupils as determined by school policy and the provision that the school is able to provide. Schools refer to this as 'The Special Education Needs Information Report.'

## **Questions**

Please read the 13 questions below for more information about the Special Education Needs Information Report for Highfield Community Primary School.

### **Question 1**

**Who are the best people to talk to in this school about my child's difficulties with learning/special educational needs or disability (SEND)?**

**The Headteacher – Mrs C Spencer**

Responsible for:

- The day to day management of all aspects of the school, this includes the support for children with SEND
- Making sure that your child's needs are met but they will give responsibility to the Special Educational Need and Disabilities Coordinator (SENDCo) and class teachers
- Making sure that the Governing Body is kept up to date about issues relating to SEND

**The SENDCo - Mrs H Porthouse**

Responsible for:

- Developing and reviewing the school's SEND policy
- Coordinating all the support for children with SEND
- Ensuring that you are
  - involved in supporting your child's learning
  - kept informed about the support your child is getting
  - involved in reviewing how they are doing
  - involved in planning for their future
- Writing pupil progress targets/ individual support plans with the class teacher, and ensuring these are shared and reviewed with parents at least twice a year
- Liaising with all the other people who may be coming into to school to help support your child's learning e.g. Speech and Language Therapy, Educational Psychology etc.
- Updating the school's SEND register (a system for ensuring that all the SEND needs of pupils in this school are known) and making sure that records of you child's progress and needs are kept
- Providing specialist support for teachers and support staff in the school so that they can help children with SEND in the school to achieve the best progress possible
- Ensuring all staff working with the student in school are helped to deliver the planned work/programme so the student can make the best possible progress. This may involve the use of additional adults, outside specialist help and specially planned work and resources

## **The Class teacher**

Responsible for:

- Checking on the progress of your child and identifying, planning and delivering any additional help your child may need (this could be things like targeted work, additional support) and letting the SENDCo know as necessary
- Writing pupil progress targets/ individual support plans with the SENDCo, and sharing and reviewing these with parents at least twice a year
- Personalised teaching and learning for your child as identified on his/her Support Plan
- Ensuring that the school's SEND Policy is followed in their classroom and for all the pupils they teach with any SEND

## **The Teaching Assistants - work with the class teacher to identify areas of support for students with SEND**

Responsible for:

- Supporting students to access the curriculum
- Helping to implement differentiation and specialist support strategies in the classroom
- Keeping students focused on learning activities during lessons
- Help students to develop effective ways of becoming independent learners
- Pass on any concerns regarding progress/emotional and social development to the class teacher and SENDCo

## **The SEND Governor – Mrs V. Chilvers**

Responsible for:

- Making sure the school has an up to date SEND Policy
- Making sure the school has appropriate provision and has made necessary adaptations to meet the needs of all students in the school
- Making sure that the necessary support is given for any child who attends the school, who has SEND.

### **Question 2**

**What are the different types of support available for children with SEND in our school?**

#### **a) Class teacher input via targeted classroom teaching**

**For your child this would mean:**

- That the teacher has the highest possible expectations for your child and all pupils in their class
- That all teaching is built on what your child already knows, can do and can understand
- Different ways of teaching are in place so that your child is fully involved in learning in class. This may involve things like using more practical learning

- Specific strategies (which may be suggested by the SENDCo) are in place to support your child to learn
- Your child's teacher will have carefully checked on your child's progress and will have decided that your child has a gap or gaps in their understanding/learning and needs some extra support to help them make the best possible progress

### **b) Specific group work**

Intervention which may be:

- Run in the classroom or outside
- Run by a teacher or a Teaching Assistant (TA)

### **c) Specialist groups run by outside agencies e.g. Speech and Language Therapy**

#### **SEN Code of Practice January 2015: SEN Support (K)**

This means they have been identified by the SENDCo/class teacher as needing some extra specialist support in school from a professional outside the school. This may be from:

- Local Authority central services such as the Special Educational Needs Inclusion Team (SENIT), the Education Psychology Service or Behaviour Support Service
- Outside agencies such as Speech and Language Therapy (SALT), Occupational Therapy, Emotional Wellbeing Team

#### **What could happen?**

You may be asked to give your permission for the school to refer your child to a specialist professional e.g. a Speech and Language Therapist or Educational Psychologist. This will help the school and you understand your child's particular needs better and be able to support them better in school.

The specialist professional will work with your child to understand their needs and make recommendations as to the ways your child is given support.

#### **d) Specified Individual support**

This type of support is available for children whose learning needs are, severe, complex and lifelong.

This is usually provided via an Education, Health and Care Plan (EHCP) – which replaces the previous 'Statement of Special Educational Needs.' This means your child will have been identified by professionals as needing a particularly high level of individual or small group teaching.

This type of support is available for children with specific barriers to learning that cannot be overcome through the methods and strategies readily available to the school.

#### **For your child this would mean:**

- The school (or you) can request that Local Authority Services carry out a statutory assessment of your child's needs. This is a legal process which sets out the amount of support that will be provided for your child
- After the request has been made to the 'Panel of Professionals' (with a lot of information about your child, including some from you), they will decide whether they think your child's

needs (as described in the paperwork provided), seem complex enough to need a statutory assessment. If this is the case, they will ask you and all professionals involved with your child to write a report outlining your child's needs. If they do not think your child needs this, they will ask the school to continue with the current support

- After the reports have all been sent in, the 'Panel of Professionals' will decide if your child's needs are severe, complex and lifelong. If this is the case, they will write an Education Health and Care Plan (EHCP). If this is not the case, they will ask the school to continue with the current level of support and also set up a meeting in school to ensure a plan is in place to ensure your child makes as much progress as possible
- The EHCP will outline the number of hours of individual/small group support your child will receive from the LA and how the support should be used and what strategies must be put in place. It will also have long, and short term, goals for your child
- The additional adult may be used to support your child with whole class learning, run individual programmes or run small groups including your child

### **Question 3**

#### **How can I let the school know I am concerned about my child's progress in school?**

If you have concerns about your child's progress you should speak to your child's class teacher initially.

If you continue to be concerned that your child is not making progress, you may speak to the Special Education Needs Coordinator (SENDCo).

The school SEND Governor can also be contacted for support.

### **Question 4**

#### **How will the school let me know if they have any concerns about my child's learning in school?**

If your child is identified as not making progress, the school will set up a meeting to discuss this with you in more detail and to:

- listen to any concerns you may have
- plan any additional support your child may need
- discuss with you any referrals to outside professionals to support your child's learning

### **Question 5**

#### **How is extra support allocated to children and how do they progress in their learning?**

The school budget, received from Gateshead LA, includes money for supporting children with SEND.

The Head Teacher decides on the deployment of resources for Special Educational Needs in consultation with the school governors, on the basis of needs in the school.

The Head Teacher and the SENDCo discuss all the information they have about SEND in the school, including:

- the children getting extra support already
- the children needing extra support

- the children who have been identified as not making as much progress as would be expected and decide what resources/training and support is needed

The child's view will be sought informally and for review meetings; this may not always be possible with very young children / children with delayed development.

Schools identify the needs of their pupils on a school provision map which for SEND pupils identifies all resources/training and support required. These are reviewed regularly and changes made as needed.

### Question 6

**Who are the other people providing services to children with SEND in this school?**

#### **School provision**

- Teaching Assistants / Learning Support
- Breakfast club / After school club
- School clubs
- Attendance Officer

#### **Local Authority Provision delivered in school**

- Special Educational Needs Inclusion Team (SENIT), comprising of:
  - Low Incidence Needs Team (LINT) specialising in hearing and/or vision impairment
  - High Incidence Needs Team (HINT) specialising in one or more areas e.g. Specific Learning Difficulties (SpLD)/Dyslexia; physical and medical needs; complex social communication needs including autism; speech, language and communication needs; general learning difficulties
- Educational Psychology Service
- Sensory Service for children with visual or hearing needs
- Behaviour Support Service

#### **Health Provision delivered in school**

- School Nurse

### Question 7

**How are the teachers in school helped to work with children who have a SEND and what training do they have?**

Staff within school have different levels of expertise in order to support children with SEND:

- **awareness** – this is basic awareness of a particular type of SEND. All staff who come into contact with the child will have this level of training and it will be carried out by the SENDCo, SENIT, Educational Psychologist or other specialist service
- **enhanced** – this level of training will be carried out by staff working with the child regularly and will focus on how teaching and learning can be adapted to meet the child's needs. The training can be carried out by SENIT, Educational Psychologist, staff from special schools or other specialist services
- **specialist** – this is in-depth training about a particular type of SEND for staff who will be advising staff who support children at an enhanced level. This could be a specialist SEND teacher or a SENDCo if they hold appropriate qualifications

### **Question 8**

#### **How will the teaching be adapted for my child with SEND?**

Class teachers plan lessons according to the specific needs of all groups of children in their class and will ensure that your child's needs are met.

- Support staff, under the direction of the class teacher, can adapt planning to support the needs of your child where necessary.
- Specific resources and strategies will be used to support your child individually and in groups.
- Planning and teaching will be adapted on a daily basis if needed to meet your child's learning needs.

### **Question 9**

#### **How will we measure the progress of your child in school?**

Your child's progress is continually monitored by his/her class teacher.

- His/her progress is reviewed formally every term in reading, writing and numeracy
- If your child is in Year 1 or above, a more sensitive assessment tool can be used, which shows their attainment in more detail
- At the end of each Key Stage all children are required to be formally assessed using Standard Assessment Tests (SATs). This is something the government requires all schools to do and are the results that are published nationally.
- Children may have an individual support plan/personal targets which will be reviewed, and a future plan made.
- Teachers meet with SENDCo on a termly basis as part of SEND pupil progress meetings
- The progress of children with an EHCP is formally reviewed at an Annual Review, with all adults involved with the child's education
- The SENDCo will also check that your child is making good progress within any individual work and in any group that they take part in

### **Question 10**

#### **What support do we have for you as a parent of a child with a SEN?**

The class teacher is regularly available to discuss your child's progress or any concerns you may have and to share information about what is working well at home and school so similar strategies can be used.

- The SENDCo is available to meet with you to discuss your child's progress or any concerns/worries you may have.
- All information from outside professionals will be discussed with you with the person involved directly, or where this is not possible, in a report.
- Personal progress targets/individual Support Plans will be reviewed with your involvement.
- Homework will be adjusted as needed to your child's individual needs.
- A home/school contact book may be used to support communication with you, when this has been agreed to be useful for you and your child.

### **Question 11**

#### **How is Highfield Community Primary School accessible to children with SEND?**

- The school is fully compliant with DDA requirements
- The school is on one level with easy access and wide or double doors
- There is a disabled toilet
- We ensure, wherever possible, that equipment used is accessible to all children regardless of their needs
- After school provision is accessible to all children including those with SEND
- Extra curricular activities are accessible for children with SEND
- The school has a separate accessibility policy

### **Question 12**

#### **How will we support your child when they are leaving this school? Or moving on to another class?**

We recognise that transitions can be difficult for a child with SEND and take steps to ensure that any transition is as smooth as possible.

#### **If your child is moving to another school:**

- We will contact the school SENDCo and ensure he/she knows about any special arrangements or support that need to be made for your child.
- We will make sure that all records about your child are passed on as soon as possible.

#### **When moving classes in school:**

- Information will be passed on to the new class teacher in advance and in most cases, a planning meeting will take place with the new teacher. Individual support plans will be shared with the new teacher.
- If your child would be helped by a book to support them understand moving on then it will be made for them.

#### **In Year 6:**

- The SENDCo will discuss the specific needs of your child with the SENDCo of their secondary school.
- Your child will do focused learning about aspects of transition to support their understanding of the changes ahead.
- Where possible your child will visit their new school on several occasions and in some cases staff from the new school will visit your child in this school.

### **Question 13**

#### **What Emotional and Social Development support do we have for a child with a SEND?**

We recognise that pupils with SEND may well have Emotional and Social Development needs which may require support in school.

- The emotional health and well-being of all our pupils is very important to us
- We have a robust Child Protection Policy in place; we follow National & LA Guidelines

- We have a robust Behaviour and Discipline Policy in place
- The Headteacher, Deputy Head Teacher and all staff continually monitor the emotional health and well-being of all our pupils
- We are an anti-bullying school

### **Complaints**

Parents/carers can contact the Special Educational Needs and Disability Information and Advice Support Services (SENDIASS) which is run by Barnardos in Gateshead (tel 0191 4784667). This is a free, confidential service for young people who have SEND and their parents/carers. The service is available whether or not the young person has an Education, Health and Care Plan.
